

PRIOR PUBLICATION IN THE COMMONWEALTH REGISTER AS PROPOSED RULES AND REGULATIONS Volume 40, Number 10, pp 040980–86, of October 28, 2018

ACTION TO ADOPT THESE PROPOSED RULES AND REGULATIONS: The Commonwealth Ports Authority HEREBY ADOPTS AS PERMANENT the amendment to NMIAC § 40-20.2-201, which was published in the Commonwealth Register pursuant to the procedures of the Administration Procedure Act, 1 CMC § 9104(a). I certify by signature below that as published, such adopted regulations are a true, complete, and correct copy of the referenced Proposed Regulations, and that they are being adopted without modification.

**PRIOR PUBLICATION**: These regulations were published as Proposed Regulations in Volume 40, Number 10, pp 040980–86 of the Commonwealth Register.

AUTHORITY: The authority for promulgation of regulations for CPA is set forth in 2 CMC § 2122.

**EFFECTIVE DATE:** These amendments will become effective ten days after publication of this Notice of Adoption in the Commonwealth Register. 1 CMC § 9105(b).

**COMMENTS AND AGENCY CONCISE STATEMENT**: During the 30-day comment period, the Authority received no comments regarding the proposed regulations. No individual requested the Authority issue a concise statement of the principal reasons for and against the adoption of the proposed amendments. At a Seaport Committee meeting held December 10, 2018, the Committee agreed to recommend to the Board of Directors that the proposed regulations be adopted without further revisions. The Board of Directors adopted the proposed regulations as final at the December 18, 2018, Board of Directors Meeting.

**TERMS, SUBSTANCE, AND DESCRIPTION OF THE SUBJECTS AND ISSUES INVOLVED**: The adopted regulation amends NMIAC § 40-20.2-201(a)(1) and provides the new section NMIAC § 40-20.2-201(a)(3). Section 40-20.2-201(a)(1) is amended to indicate that the wharfage rate for prefabricated modular units is not \$11.40. Section 40-20.2-201(a)(3) is added to establish the wharfage rate for prefabricated modular units at \$5.70. Additionally, NMIAC § 40-20.2-201(a)(3) defines "prefabricated modular units" as "modules that contain finished interiors of completely assembled structures, that do not contain other materials that could otherwise be categorized as cargo, and that could not otherwise be classified as doublewides or mobile homes."



# Proposed Amendments to the Personnel Rules and Regulations of the Commonwealth Ports Authority

The Executive Director of the Commonwealth Ports Authority hereby notifies the public that the Commonwealth Ports Authority intends to promulgate amendments to its Personnel Rules and Regulations.

**INTENDED ACTION TO ADOPT THESE PROPOSED AMENDMENTS TO THE PERSONNEL RULES AND REGULATIONS OF THE COMMONWEALTH PORTS AUTHORITY:** Notice is hereby given pursuant to 1 CMC § 9104(a) of the Administrative Procedure Act that the Commonwealth Ports Authority intends to promulgate the following additional section to the Personnel Rules and Regulations.

**TERMS, SUBSTANCE, AND DESCRIPTION OF THE SUBJECTS AND ISSUES INVOLVED:** The proposed amendments add NMIAC § 40-40-620 to the Personnel Rules and Regulations of the Commonwealth Ports Authority. Section 40-40-620 states that directives and other memoranda issued by the Governor of the Commonwealth of the Northern Mariana Islands that affect personnel matters shall be made applicable to the Commonwealth Ports Authority, that the Commonwealth Ports Authority Executive Director may interpret and modify substantive provisions of such directives and other memoranda to tailor those documents to the needs of the Commonwealth Ports Authority, and that any rules or regulations that conflict with such directives, memoranda, or interpretation or modification of such directives or memoranda will be suspended until such directives or other memoranda are deemed no longer effective.

**AUTHORITY:** The following proposed amendments have been fully reviewed by the CPA Board of Directors, which exercises all powers vested in the Commonwealth Ports Authority. During the board meeting held on December 18, 2018, the Board of Directors approved the proposed amendments for publication in the Commonwealth Register for Notice and Comment pursuant to the Administrative Procedure Act and for approval by the Attorney General pursuant to 1 CMC § 2153(e). The Commonwealth Ports Authority has the authority to promulgate these regulations pursuant to 2 CMC § 2122.

**DIRECTIONS FOR FILING AND PUBLICATION:** These Proposed Regulations shall be published in the Commonwealth Register in the section on Proposed and Newly Adopted Regulations, 1 CMC § 9102(a)(1), and posted in convenient places in the civic center and in local governments in each senatorial district, both in English and in the principal vernacular. 1 CMC § 9104(a)(1).

#### Commonwealth Ports Authority <u>PROPOSED AMENDMENT TO THE PERSONNEL RULES AND REGULATIONS</u>

#### § 40-40-620 Governor Directives and Other Memoranda

(a) Directives and other memoranda issued by the Governor of the Commonwealth of the Northern Mariana Islands that affect personnel matters shall be made applicable to the Commonwealth Ports Authority. The Executive Director may interpret and modify substantive provisions of such directives and other memoranda in order to tailor such documents to the Commonwealth Ports Authority.

(b) Any rules or regulations that conflict with the Governor's directives and memoranda in subsection (a) or the Executive Director's interpretation or modification of such documents shall be suspended until such directives or other memoranda are deemed no longer effective or applicable to the Commonwealth Ports Authority by either the Governor of the Commonwealth of the Northern Mariana Islands, the Commonwealth Ports Authority Executive Director, or the Commonwealth Ports Authority Board of Directors.
