DUTIES:

Advocate the rights of victims to the criminal justice system, local leaders and the community. Inform and provide victims about referral services. Plan, develop and coordinate the implementation of a range of high quality responsive services to address the identified needs of victims affected by all crimes. Provide crisis counseling and case management. Ensure services provided are in accordance with VAWA policies and procedures and meet the requirements of the funding agreement. Develop and maintain relationships with key government and non-government service providers, and engage key stakeholders in joint activities and projects. Identify and participate in relevant interagency meetings and forums to raise awareness and advocate on crimes. Identify opportunities for innovative projects for collaborative partnerships with community partners. Review pending cases daily, inform victims about their case status, and discuss concerns with other Taskforce members. Assist victims in obtaining medical insurance, child care, employment, legal representation, welfare, vocational training, housing and other types of assistance necessary for the victim to gain and sustain independence. Assist in the submission of data and case information for quarterly reports. Make home visits to monitor the progress of victims and ensure their safety. Provide mediation between the victim, perpetrator, and their children if deemed appropriate. Perform other related duties as assigned.

MINIMUM QUALIFICATION REQUIREMENTS:

Any combination equivalent to graduation from an accredited college or university with an AS Degree in Social Work, Education, Social Science or related field plus one (1) year of case-worker, family or children assistance, or related work experience.
